TERMS AND CONDITIONS FOR PRIVATE HIRE OF

CLUBHOUSE PREMISES

1. Private use of the Clubhouse is always granted at the discretion of the Committee. If the Clubhouse is required for club use, it may not be available for hire on the date required.
2. The Hirer must be a Full or Temporary member of the Club and be present at the function.
3. All persons attending the function must be invited guests of the member hiring the Clubhouse or full Club members or Temporary members.
4. Numbers in the building are limited to 200 at any one time.
5. The licensing laws which affect the Club must be complied with.
6. No drinks may be sold or supplied other than by the Club over the Club

bar. Should you wish to supply your own wine for your event there will be a **corkage charge of £5.00 per bottle.**

7. Persons under the age of 18 cannot be sold alcohol.
8. Payment in full is required at the time of booking to cover the cost of hire. Members hiring the Club are responsible for any damage caused. Hirers must leave the building, equipment and surroundings as they found them. Additional cleaning or repairs will be charged for at cost.
9. Aerosols containing any substance or other items (eg "silly string) likely to damage the premises are not permitted.
10. The hirer must not make any financial gain from hiring the Club. Exception to this rule may be made for charitable events by prior agreement.
11. The Club Kitchen and equipment may only be used by Caterers recommended and authorised by the Club.
12. The lower floor of the premises (sailing facilities) are not to be used.
13. The bar will close at 2400 hours.
14. The Clubhouse is only available for hire to Club members for a function to be attended only by Club members and their guests. Any person hiring the Clubhouse must apply for temporary membership at least 7 days prior to the event.
15. Not less than 3 days before the date of the hiring the hirer shall deliver a list of all persons who will be attending the function to the responsible Club officer. No person whose name is not on the list may attend the function unless they are a Club member or bona fide guest of a Club member. Persons named in the list will be granted temporary membership of the Club for the duration of the function and shall be subject to the rules of the Club
